CONFIRMATION AFFIDAVIT OF JANE GOODWIN

JANE GOODWIN, being duly sworn, says:¹

1. My name is Jane Goodwin. I am over 21 years of age and fully competent to make this Affidavit. Unless otherwise stated, I have personal knowledge of the facts set forth in this Affidavit.

2. I make this Affidavit in support of confirmation of the Debtors' *First Amended Joint Plan of Reorganization* (the "Plan") (D.E. #222), which I have had a full and fair opportunity to review and to consult with my own independent counsel.

3. Sam Dickson and I co-own the properties located at (collectively, the "Properties"): (a) 518-522 Rear Margaret Street, Key West, Florida 33040; (b) 1124-1126 Margaret Street, Key West, Florida 33040; and (c) 1128 Margaret Street, Key West, Florida 33040; additionally, Sam Dickson and I formerly co-owned the property located 522 Margaret Street, Key West, Florida 33040.

4. I am familiar with, and consent to, the terms and conditions of the Plan as it relates to the Properties, the treatment being afforded to the creditors holding Claims with respect to such Properties, and I support confirmation of the Plan.

¹ Unless otherwise defined herein, defined terms shall have the meanings ascribed to such terms under the Plan.

5. I consent to those funds in the amount of approximately \$27,500.00 to which I am entitled to receive under the Plan from surplus proceeds from the foreclosure sale of property located at 522 Margaret Street, Key West, Florida being used to pay attorneys' fees and costs awarded to Seese, P.A. by order of the Court.

CONCLUSION

6. Based on the foregoing, I submit that confirmation of the Plan as proposed is in the best interests of the estate and creditors and that the Plan has a reasonable probability of success.
